I, Charles DuBois Willis BA, MD was born in Queens, New York in 1925. I was raised in the Seventh Day Adventist church going weekly to the City Temple in Manhattan. I graduated from the Bronx High of Science in 1944 and then went to Union College in Lincoln, Nebraska for two years of Premedical courses after which I was drafted into the US Army for one year.
